Approval of the above subject to fulfillment of the following condition :-

1. The approval period will not be extended and after class 8 to give approval or affiliation in no case shall there be any obligation.
2. Right of children to free and compulsory education act 2009 (addendum 1) and Right of children to free and compulsory education act 2011 (addendum 2) the school shall comply with the provisions.
3. The School shall admit children belonging to the nearest weaker sections and disadvantaged groups in the first class to the extent of at least 25 percent of the number of student in that class and free and compulsory education will be given to them till completion of primary education but more so even in case of pre- primary classes this standard will be complied with.
4. For children specified in paragraph 3 the school will be reimbursed under Sec. 12 (2) of the act, a Separate bank account will be provided to the school to receive such reimbursement.
5. Institution /School no capitation fee will be charged and child or his Parent or guardian shall not be compelled to undergo any screening procedure.
6. No child shall be denied admission to school for lack of proof of age, religion, cast or race, place of birth or any of these reasons.
7. i) No child admitted to school shall be held back in the same class as he belongs or shall not be expelled from school until completion of primary education.  
ii) No child shall be subjected to corporal punishment or metal torture.

- iii) No child shall be required to pass any Board examination till completion of primary education.
  - iv) Every child who has completed primary education shall be given the certificate prescribed under rule 23.
  - v) Students with disabilities or special needs will be included as per provision of the Act.
  - vi) Teachers possessing the minimum qualification prescribed under Sec.23 (1) of the act shall be appointed but more so teachers who do not hold the minimum qualification on the date of commencement of the Act will have to acquire such minimum qualification within a period 5 years.
  - vii) A teacher shall perform his or her duties as specified in Sec. 24 (1) of the Act.
  - viii) The school shall ensure that the teacher does not engage himself in private tutoring.
8. The school shall follow the syllabus prepared on the basis of the syllabus prescribed by the appropriate authority.
9. As prescribed in Sec. 19 of the schools Act it will give access to the students compared to the facilities available in the school.
10. The school shall adhere to be standards and norms specified in Sec .19 of the Act.
